AAO Council on Orthodontic Education

The AAO Council on Orthodontic Education (COE) held its annual meeting in St. Louis on Monday, October 29, 2019. The assembled council discussed various items including mechanisms to ensure adequate AAO representation at other organized meetings including the American Dental Education Association and American Dental Association Annual Sessions. Other items discussed during the meeting included the nomination of new CODA site visitors, the possible change in CODA site visitor training, the 2019 AAO Society of Educators Educational Conference, and a review of the COE budget for the 2019-2020 fiscal year. There were no particular items or decisions discussed during the meeting that would impact the broader GLAO membership. Additional information about COE discussions and activities will be provided throughout the year in future GLAO e-news issues.

American Board of Orthodontics Clinical Examination Change Update

The American Board of Orthodontics will conduct the first iteration on its new Scenario-based Oral Clinical Examination February 20-22, 2019. There has been much talk and anticipation surrounding this new examination and the profession will be eager to see how the first cohort of examinees performs on the exam. The overall modification to the board certification process appears to have peaked the interest of many individuals within the profession, as the November 2019 exam session has already amassed a wait list for interested individuals interested in completing the clinical examination. The immediate and long-term impact of this format change will begin to be more evident as time proceeds and more individuals challenge the exam.

Commission on Dental Accreditation (CODA) Standards Review Taskforce Update In the latter half of 2018, the AAO CODA taskforce completed its review of the current orthodontic CODA standards and the development of recommendations. The drafted recommendations were established by engaging a large group of stakeholders both within and outside of the orthodontic profession. The aim of these recommendations was to strengthen the education offered by all accredited orthodontic resident programs, thus producing the most knowledgeable and prepared orthodontic professionals into the workforce. These recommendations have been reviewed by the AAO Board of Trustees and approved. At this time, the recommendations have been submitted to CODA and will begin the standard vetting process. Updates on the progress of the recommendations within the CODA review process will be shared with members of the GLAO, AAO, and other stakeholders as more additional information is obtained. There will be more to come, so stay tuned.

2019 ADEA Annual Session and Exhibition

The American Dental Education Association (ADEA) will hold its Annual Session and Exhibition at the **Hyatt Regency Chicago** in **Chicago**, **Illinois** from **March 16-19**, **2019**.
