Heraclitus, a Greek philosopher who lived around 500 B.C., is quoted as saying "change is the only constant in life." Charles Darwin is often quoted as having said that the one who survives is not the strongest, nor the most intelligent, but the one who adapts and changes with the environment. So how do we adapt to what is coming? How can our specialty continue to grow and succeed? In my opinion, the answer is treatment customization. This takes us back to how we started before the preadjusted appliances. We went from individual bends to move the teeth we want and not the teeth we do not want, to a sometimes more massproduced one size fits all solution, which became so practical that could almost eliminate the operator. But it couldn't and will not, because of the amount of variation that exists in orthodontic treatment and in an orthodontic patient. Every patient is different, with different needs, different wants, and different situations. We should not act as technicians and should act as what we are, healthcare providers. It is the ability to provide customized treatment that will take us to the next level, and the technologies that have been introduced in these past few years are the tools we need to make it happen in an efficient way. Regardless if you are using fixed appliances or aligners, we now have software and hardware that allows us to have more control of what is happening in our patient's mouths, and become more efficient than ever before. And those tools cannot do it alone. They need our knowledge.

In addition during the same time, 245 orthodontists have completed their 10-year certification renewal requirements. - Written Examination: The 2023 Written
 Exam will be held on April 4 (registration is
 closed.) The 2024 Written Exam will be held
 on April 2. Both exams will be administered

 and Canada.
- Scenario-based Clinical Examination: The ONLY 2023 ABO Scenario-based Clinical Examination is scheduled for February 23-24. The 2024 Clinical Examination will be administered February 22-23 (registration is scheduled to open on March 1, 2023). The examinations will be held at Pearson-Vue Centers Worldwide.

Applications for the 2023 Lindsey O. Kesling Orthodontic Resident Scholarship Award are now available. Applications are due by April 15, 2023. Recipients will be announced during the GLAO Member Business Meeting at the GLAO Annual Session in National Harbor, Maryland, on Friday, September 22, 2023.

The Lindsey O. Kesling Orthodontic Resident Scholarship Award was created to give back to the orthodontic community in a way that helps residents, by easing a small part of their financial burden. Lindsey Kesling just graduated from Indiana University and was beginning a promising career in the orthodontic industry when accidental exposure to carbon monoxide (CO) ended her life at the age of 22. Lindsey was passionate about orthodontics and the industry. Her great grandfather, Dr. Harold D. Kesling, founded TP Orthodontics, Inc. which is still owned by the family today.

TP Orthodontics, Inc. has partnered with the GLAO to offer the Lindsey O. Kesling Orthodontic Resident Scholarship Award annually, to residents from orthodontic programs in the GLAO region. Since the inception of the scholarship in 2017, nearly \$40,000 in scholarships has been awarded to 18 residents from seven different universities in the GLAO region. In addition, over \$9,000 in product vouchers has been awarded to fifteen additional applicants.
